## **Deposit and Payment**

Reservations are not confirmed until payment has been successfully processed.

Low Season / Shoulder Season: (Dates outside High Season) A 2 nights tariff (AUD) deposit per apartment will be processed for all bookings. Balance of booking will be processed on day of arrival.

High Season: 23<sup>rd</sup> December 2016 – 14<sup>th</sup> January 2017 A 3 nights tariff (AUD) deposit per apartment will be processed for all bookings. Balance of booking will be required 30 days prior to arrival.

Payment by Visa, Master Card will incur a 2.0% surcharge, American Express incur a 2.5% surcharge

Personal Cheques are not accepted as a method of payment on arrival.

**CANCELLATION POLICY** The guest acknowledges that they are aware of the following cancellation policy.

LOW / SHOULDER SEASON Cancellation 2 weeks or more prior to arrival incur \$50 cancellation fee. If cancelled less than 2 weeks you forfeit 1 nights deposit unless we are able to re-let for the full stay.

HIGH SEASON OR SPECIAL EVENTS PERIOD Bookings cancelled prior to final payment incur a \$50 cancellation fee. The balance must be paid in full 30 days prior to arrival. No refund unless we are able to re-let for the full stay.
